Opening Meeting

1.1 Devotions

Neels opened the meeting in prayer.

Amira shared a devotion on 1 Samuel - Hannah's Prayer, and explained the lessons in leadership woven throughout.

Verse 4: . In the world we often value strength, self-sufficiency, and outward success. But Hannah reminds us that God delights in lifting the humble and bringing low the proud.

Verse 8: This is a powerful picture of redemption and elevation. In this we see that God's heart is for the lowly, for the poor, the down trodden. Do we reflect God's heart in our leadership? Do we empower others?

3. Finance Report

3.1 Finance

The Financial Report, for period ending April 2025, circulated and taken as read. The Director of Finance, Sam Bandara, was in attendance to answer any questions.

There have been some unbudgeted expenses, approved by the Board, but the Admin Budget is still under budget for this year, and YTD spend is less than the same time last year.

Neels complimented Sam on the new and improved reporting format.

Our staffing entitlement was based on a higher estimated roll, than our current actual roll. This means we have slightly more staffing entitlement which allows us to cover some relief.

Capital Works: JC COLA - use for assemblies, dance and drama and therefore would like to add wiring for sound. Quote for \$114k for Astro Turf. Need the facilities for sports too. Safe surface.

A discussion on KWT spending ensued. It was suggested to ask the Trust whether we can use Policy One money to fund the balance of the Primary astro turf. The wiring is more critical to install as it is time sensitive.

A Board member disclosed that they have written to the MoE regarding Policy One spending and read out an email reply. Another member stated that the integration agreement is grey and our requirement of the Trust is to ensure they are maintaining the buildings to an acceptable standard and that if the Trust could provide more finance at this point in time they would. A few members requested greater transparency of how Policy One money is spent. The Presiding member wrapped up and assured the Board that all money has been given back to the school.

The EP explained there are three areas that the Board may contribute Crown funds to: shade coverings, hard surfaces/astro, and playgrounds.

Sam pointed out a typo on page 2 of the Finance Report. Total known materials gains should read \$115k (not \$135k).

4.1 Annual PAT Report

The Annual PAT Report circulated and taken as read. Lisa Lambert, Associate Principal with Assessment Portfolio, was in attendance to answer questions.

The Board gave Lisa speaking rights.

This year is the first year that schools began using the new revised Reading Comprehension Progressive Achievement Tests. Due to new Ministry of Education requirements to administer standardised tests (not necessarily PAT's) twice each year from 2026, we are doing PATs twice this year as part of our investigation.

- Progress has been made at all year levels with areas of particular strength and pleasing progress in various PATs, cohorts, and quartiles.
- Listening Comprehension has shown some improved results compared to recent years.
- We will look at including separate data for priority learners next year.
- 53% of Primary School students are ESOL.

5.1 Executive Principal's Report

The Executive Principal's Report was circulated and taken as read.

The EP highlighted the following areas of his report:

- · Special Character continues to flourish.
- We have 1000 students on the waitlist and have just had the biggest open day attendance ever. We will need the roll increase to be approved.
- Kahui Ako has been disestablished to allow a greater focus on funding Learning Support. The Learning Support co-ordinator will be funded by the MoE instead of by the school.
- Arts Block the Trust continues to wait for building consent, but we are still on track for completion for the start of February 2026.
- The Learning Support Hub is on track and the designs provided by the proprietor are great.

A board member flagged that the PA systems are still on the Hazard register. The proprietor got quote, which is way more than anticipated. The proprietor is looking at other options. The EP is confident that the school is compliant but the school is still using work-arounds.
